



1996 the European Civil Aviation Conference (ECAC) launched SAFA.

In 2004 (Flash Airline Accident) the European Parliament published a Directive creating a legal obligation on EU Member States to perform ramp inspections on third country aircraft.

EU Member States were provided with a two-year transition period for implementation.

- ▶ By 2009 ICAO Annex 6 Part I & III were amended to incorporate "amendments to definitions and SARPs to strengthen the oversight and requirements of foreign operators, and to harmonize the Air Operator Certificate in content and layout.
- ➤ Also Doc 8335 was re-issued to incorporate "Part VI – State Responsibilities regarding Commercial Air Transport Operations by Foreign Operators"

In 2011 the ATTC agred to develop:

TERMS OF REFERENCE OF EXCHANGE INFORMATION ON RAMP INSPECTION DATA (EIRID)

Which referred to the establishment of a database held in the ICAO Regional Office.

Such database was not available at the time.

In 2013 the EU – ASEAN Aviation Transport Integration Project was launched (AATIP).

The mutually agreed workplan contained the activity:

"Establish a framework to share (foreign operators) ramp inspection information among ASEAN Member States"

The ToR also included the setup of a dedicated office to collect, analyse and distribute results amongst the participating states.

XFOSA ToR

The AFOSA ToR was never officially presented to the ATWG.

Instead, on the basis of assuming that a dedicated office, staff and equipment would be too costly, Malaysia and Singapore presented the plan to develop a more simple and cheaper way of achieving the intended AFOSA results.

In May 2016

The first AFOSA Committee meeting took place in Singapore and it was decided to adopt the draft AFOSA Handbook containing procedures how to submit FAO ramp inspections, analalyse and distribute results.
