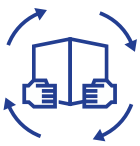

1 Trade Facilitation & Transparency

2 Standards & Conformity Assessment
Support the harmonisation of standards and regulations particularly for healthcare and agro-food sectors and support ASEAN conformity assessment and accreditation.
