 - Flight cancellations
 - Denied Boarding
 - Missed flight connections



On-Time Performance (OTP)

CAB Resolution No. 26 (BM 04-05-30-2019)

 The CAB requires the submission of monthly reports on On-Time Performance



Misuse of Slots

Joint Memorandum Circular No. 2019-01

- This regulation provides for the instances which constitute as slot misuse.
- It provides for penalties for erring air carriers.



Student Fare Discount Act

Republic Act NO. 11314

- Signed on 17 April 2019
- It mandates the grant of 20% discount on air fares for students.
- Currently drafting the Implementing Rules and Regulations



Compassionate Fares

CAB Resolution No. 59 (BM 06-09-27-2018)

 After consultation with the airlines, this policy is now fully implemented



Fuel Surcharge

CAB Resolution No. 44 (SBM 05S-08-17-2018)

 Provides a Matrix on Fuel Surcharge and Guidelines on the Imposition



Chronically Delayed Flights

 Currently studying and drafting a policy on chronically delayed flights



- Task Force on Accessibility is providing trainings on handling PWD air passengers
- DOTr and CAB personnel, airport authorities and airport personnel



Currently Implementing:



Cooperating on the inter-agency drafting of the Implementing Rules and Regulations of Batas Pambansa Blg. 344 (Accessibility);

Conducting further study on priority seat-reservation in aircraft for PWDs;

Conducting further study on mandating airlines to put special tags on checked-in wheelchairs as these are items that may need special consideration;

Planning the next conduct of PWD Rights Awareness Seminar and Sensitivity Training for PRAOs, and other airport front-liners; and

Monitoring airlines' compliance with existing CAB rules and regulations on PWD's and Senior Citizens' Concerns.
